Proposal

- Amends Title 21, Land Development Code
- Chapter 11, Special Use Standards Section 26, Residential Short-Term Rental (STR); and
- Chapter 15, Sensitive Area Overlay Zone, Section
 7, Violations, enforcement and penalties.





Proposed Code Amendment

- Purpose of the Code Amendment:
- •Remove civil fine amounts from the Land Development Code.
- •Relocate them to the fee schedule.
- •Other minor clarifying text amendments associated with removing the fines.



Planning Commission Recommendation to City Council

Forward a positive recommendation to the City Council to amend Title 21, Chapters 11 and 15, of the Sandy Municipal Code, relating to removing fines from the Land Development Code based on the analysis and findings in the staff report.





Proposed Code Amendment Title 1 and 19, Sandy City Code Fee Schedule amendments

Proposal

- Amends Title 1 & 19, Sandy City Code and the Fee Schedule
- Title 1, Chapter 4, Administrative Code Enforcement Multiple code sections; and
- Title 19, Chapter 1, Administration, Section 7, Abatement of Weeds, Garbage or Refuse.





Proposed Code Amendment

- •Purpose of the Code Amendment: to clarify applicability of the City's code enforcement process to violations of local ordinances and State statutes.
- •Adding "applicable state law".
- •Removing the requirement to pay a "filing fee";
- •Modifying the requirement that a hearing must be held within 35 days vs 21 days.
- •Other minor clarifying text amendments associated property abatements.
- •Title 19 is amended to remove the section that outlines the process to have a hearing with the Hearing Officer. Similar language in Title 1.
- •Add fines to the Fee Schedule that the City Council reviews annually.

Total accrued fines for any violation shall not exceed \$5,000 per violation. There shall be no maximum fine amounts related to Sensitive Area Overlay Zone violations.

STR Violations (per 21-11-26 (g) see code section for additional regulations related to fines.

For the first violation within any 12-month period, the penalty shall be \$500. For a second violation within any 12-month period, the penalty shall be \$750.

For a third violation and all additional violations within any 12-month period the penalty shall be \$1,000.

For any violation within any 12-month period following the third violation, the penalty shall be \$1,000.
