Mike Wilcox presented this item to the Planning Commission.

Monica Collard asked to clarify the term of turf and asked if there's anything in the code that requires a barrier with xeriscape.

Mike Wilcox said that weed barriers are required with xeriscape and briefly spoke about maintenance.

Monica Collard asked if astro turf could be added as permitted use.

James Sorensen said there are several lawns that are full turf in the front.

Mike Wilcox said we could provide a provision that would allow for both live and artificial.

Monica Collard said it could be a good thing with water conservation.

Richard Benham from Public Utilities said that there is no minimum but there is a maximum of landscaping of 20% and that if they wanted to specifically say astro turf is allowed for permitted use they could include that.

Dave Bromley said that this could get confusing in the ordinance with having 20% live turf, 20% artificial turf and 60% mixed.

Michael Christopherson said he doesn't see a purpose for adding references for artificial turf if it's not prohibited or restricted.

Mike Wilcox said turf areas are not required.

Cameron Duncan said it's important to have a minimum live plant requirement.

Jamie Tsandes recommends not adding artificial turf in the ordinance. Jamie asked for clarification on turf allowed in park strips and if the city has many park strips wider than 8'

Mike Wilcox said the city does have park strips that are 8' and wider and that astro turf is allowed.

Jamie Tsandes asked if the city has thought about requiring trees to be placed on a different irrigation zone and not allowing trees and grass to be planted in a park strip.

Mike Wilcox pointed out, in Exhibit A, that grouping plants together is encouraged but not required.

Richard Bernham said there's also language for drip irrigation.

Jamie Tsandes recommends the language to be spelled out saying trees need to be watered on a separate irrigation zone because it could be interpreted in different ways.

Abi Holt from Public Utilities said that the state has some requirements that they'll require from all municipalities that want to continue to receive funding from the state for local programs like flip your strip and localscape.

Monica Collard opened this item to public comment.

Steven Van Maren, 11039 S. Lexington Circle, asked if the slope should be the same and asked about bark mulch.

Monica Collard closed this item to public comment.

Dave Bromley replied to Steve Van Maren's comment, regarding the slope, that it seemed ok.

Mike Wilcox clarified that the reason the slope's are different is because it's for different areas.

Dan Media said that bark mulch is not allowed in park strips only rock.

A motion was made by Michael Christopherson, seconded by Cameron Duncan that the Planning Commission forward a positive recommendation to the City Council to amend Title 21, Chapter 25, Landscaping Standards, of the Sandy Municipal Code, as shown in the revised Exhibit A as presented in the meeting and based on the two findings outlined in the staff report.
