Doug Wheelwright introduced this item to the Planning Commission.

Quinn Deitlein, 4288 W 11475 S, South Jordan, said that the most critical need for the additional space is for rehearsals.

David Hart asked if it will seat 300.

Quinn Dietlein said it's to be determined.

David Hart asked if patrons would be using it and if it's black box seating.

Quinn Dietlein said it started out as black box seating.

David Hart asked how would patrons access the space.

Quinn Dietlein said there's a main alleyway between the main theatre and the parking structure that will have a glass partition, at it's south end, where patrons can enter. They can also enter through the formal Hale Centre Theatre entrance.

Lyle Beecher, 3115 E Lyon Lane, Holladay, spoke about the materials used for the project.

Steven Wrigley wanted to know what the distance is between the top of the roof of the new building to the existing parking structure and asked why they decided to use paint on rough concrete instead of stucco to resurface the exposed wall.

Brad Beecher, 3115 E Lyon Lane, Holladay, said that the distance from the roof to the top of the parking garage is 26' 9" but from the parapit it's 24' 2". From the top of the screen wall, which is where your eye will judge the height of the structure against the parking lot, to the top of the garage it's 13' 6". From the top of the tower's highest point is 6'11".

Lyle Beecher spoke about two different areas of the parking structure that staff has concerns about and made some suggestions to the Planning Commission that the south side is painted and suggested not to do anything to the parking structure that's owned by Mountain America Credit Union.

Dave Bromley asked what color they were going to use to paint the south side.

Lyle Beecher said the paint would match the concrete and not the Hale Theatre.

David Hart asked if they've received permission to paint the parking structure owned by Mountain America Credit Union and who is going to maintain the paint

Lyle Beecher said they've spoken to Mountain America Credit Union.

David Hart asked if there's been a discussion with Mountain America Credit Union to not do anything to the parking structure and he doesn't feel that painting it makes sense. David also made suggestions for concrete wash and stucco.

Lyle Beecher said yes there's been a discussion with Mountain America Credit Union and said that concrete wash and stucco are very expensive.

Cameron Duncan said he doesn't feel anything needs to be done with the parking structure.

Daniel Schoenfeld said he feels the same as David Hart.

Dave Bromley said he feels the same as David Hart.

Steven Wrigley said his concern is putting paint on rough concrete and the difficulty of maintenance of the paint.

Jamie Tsandes said visually the paint would look nice and if the owner is willing to take on the maintenance burden then that would be great otherwise just leave it alone.

Doug Wheelwright said that staff had the same concerns and spoke about screening relating to the architectural ordinance. The matter of enhancing the portion of the existing parking structure above the proposed roof of the new theater is to be determined by the Planning Commission.

David Hart asked if getting the same colored brick or limestone would be an issue due to supply chain demands.

Lyle Beecher said they have already checked with Interstate Brick which is the major brick provider in the area and the same brick is available now.

Ron Mortimer opened this item for public comment.

Ron Mortimer closed this item for public comment.

A motion was made by David Hart, seconded by Daniel Schoenfeld, that the Planning Commission find that the proposed building addition's preliminary site plan review be determined to be complete and to determine that the final building's architectural design, building materials and colors as proposed, be approved for the Hale Centre's Beehive Academy Theatre located at 9886 S. Monroe St., based upon the three findings and five conditions of approval detailed in the staff report with an amendment to finding #3 that the building height as proposed provides adequate screening as decided by the Planning Commission.
