Subject: Council Member Stroud proposed amendment to the FY 2026 Tentative Budget – Hazardous Concrete, an additional Animal Services Officer, and Police Ammunition

---

**Description:** Appropriation of \$100,000 in additional funding towards Hazardous Concrete Repair, an additional Animal Services Officer, and Police Ammunition.

### Proposal Summary:

This amendment proposes:

1. A one-time appropriation of an additional \$100,000 to hazardous concrete repair (Exhibit A).
2. A new Animal Services Officer funded at \$89,872 (Exhibit B)
3. An ongoing increase of \$5,000 for Police Ammunition (Exhibit C)

### Narrative:

I want to emphasize the critical importance of allocating sufficient funding for hazardous concrete repair in our upcoming budget. Beyond the obvious aesthetic concerns, failing concrete infrastructure, such as crumbling sidewalks, poses a significant and immediate threat to public safety. Investing now in these essential repairs is not merely a matter of maintenance; it is a fundamental responsibility we owe to our constituents to ensure their safety and maintain the structural integrity of our shared public spaces.

Hiring a new Animal Services Officer is a critical investment in the well-being and safety of our entire community, both human and animal. This additional officer will enhance our capacity to respond promptly to calls regarding stray, injured, or aggressive animals, reducing potential public safety risks and ensuring humane treatment for animals in distress.

Ensuring our police department has access to the appropriate amount of ammunition is fundamental to maintaining public safety and officer preparedness, particularly concerning firearms training. Regular, realistic training with live ammunition is indispensable for officers to

develop and maintain critical marksmanship skills, weapon proficiency, and decision-making under pressure. Without adequate ammunition, officers cannot engage in the frequent and varied drills necessary to practice complex scenarios, refine their aim, manage recoil/possible weapon malfunction and adapt to dynamic situations. This directly impacts their ability to respond effectively and safely in high-stress, real-world encounters, where split-second decisions and precise actions are paramount. Investing in sufficient ammunition for training is not an extravagance, but a vital component of equipping our officers to protect themselves and the community.

I am requesting that the Council consider approving my proposals, as drafted in Exhibits A, B, and C. While I have not changed my proposal from June 10<sup>th</sup>. In the interest of clarity, I have decided to describe each request within its own exhibit.
