Council Chair Zach Robinson invited the public to participate in General Citizen Comments.

Ms. Marilyn Larson expressed concerns with utilizing capital project funds for a recreation center and believes the funds should be allocated to the fire station. She would like for the public to vote on which capital projects should be funded.

Ms. Rebecca Colley said it is very difficult for residents to get to the meeting by 5:15 pm to participate in citizen comment. She expressed support for using capital project funds to build a new fire station.

Ms. Patricia Jones does not think there should be a meeting on Election day. She spoke about the GO Bond item on the agenda this evening. She suggested the Council conduct a city survey to gather feedback from the residents regarding the prioritization of capital projects.

Mr. Clint Juhl thinks the Council and Mayor have done a fantastic job addressing the capital project needs of the city. He expressed support for the fire station and for Alta Canyon Recreation Center. He thanked the Council for their service and told them to keep up the great work.

The committee suggested the following amenities be considered by the Council to be included in the design of the recreation center: multi-use indoor courts, indoor walking track, cardio and aerobics areas, weight room, and child care room. He provided an explanation and introduction to impact fees, detailed the impact fee process, the preparation of the Impact Fee Facilities Plan (IFFP) and analysis. Mr. Philpot presented a summary of proposed fees, a growth comparison, and detailed the next steps to move forward which include finalizing the IFFP/IFA based on Council feedback and the noticing and holding of a public hearing at a future City Council Meeting.
