The property is located at 348 East 8000 South and the applicant is requesting a rezone to RM12. The property owner provided additional details and expressed his support for the rezone. Council presented proposed amendments to the FY 2023 Budget for consideration.

Council Member Housman withdrew her proposal.

Council Member D'Sousa presented her budget amendment to increase the current funding to the Sandy Youth Council by \$3,000 to \$5,500. She provided details of the budgeted expenses and recommended funding source.

Council Members Robinson and Stroud presented a budget amendment to fund two FTE's for the Fire Department and provided recommendations for funding this amendment. Council questions followed. Chief Cline provided additional details on possible grant funding and responded to Council questions. Brian Kelley responded to Council Member Mecham's questions.

Council Members Sharkey, D'Sousa and Earl presented a budget amendment to address the bulk waste fee assessment, funding, and proposed subsidy to the bulk waste program. She reviewed the details associated with the proposed amendment. Council Members Sharkey, D'Sousa and Earl spoke about the importance of the bulk waste program to the residents.

A lengthy Council discussion on the proposed amendments followed.

Agenda Planning Calendar Review & Council Office Director's Report

Dustin Fratto, Executive Director, invited Liz Theriault to the lectern to brief the Council on the new web page created for the Alta Canyon Sports Center. Ms. Theriault provided an overview of the new web page. Mr. Fratto also briefed the Council on upcoming Agenda items.

Council Member Business

Council Member Brooke D'Sousa invited all to attend the Sandy Club Annual Family Carnival on June 17th.

Council Member Zach Robinson gave an update from the Alta Canyon Advisory Committee meeting. The committee is engaged and functioning.

Council Member Cyndi Sharkey provided an update from the Interim ULCT Legislative Policy Committee meeting that she and Council Member Brooke D'Sousa attended. She spoke about the presentation by Robert Spendlove at the LPC meeting and asked if the Council would like to have this presentation at a future Council meeting. Council expressed an interest to schedule this presentation at a future meeting.

Council Member Ryan Mecham invited all to attend the Summer Kickoff Barbecue in Historic Sandy on June 15th. He thanked Administration, Dawn Sidwell and Tracy Cowdell for their efforts and help to organize this event.

Council Member Alison Stroud provided an update from the Historic Committee. The Heritage Festival will take place this September and is a city-wide event.

Council Member Scott Earl spoke about the speeding in Sandy City and asked for additional information from Administration regarding the new Slow Down Sandy initiative.

Council Member Marci Houseman acknowledged all those who supported the military this past Memorial Day weekend. She appreciated all the events that took place across the state. And she shared a personal story - she took her father to Layton City to visit a replica of the Vietnam War Memorial. She recommended to the community to visit this memorial if you are able to.

Mayor's Report

Mayor Zoltanski thanked the Council Members for joining the employee picnic last week. This Friday is the launch of the movies in the park at the Rio Tinto stadium. All are welcome. She spoke about the traffic and speeding concerns and is committed to enforcing traffic laws in Sandy. A week from Friday, the Mayors and Police Chiefs from across the valley are meeting at the Amphitheater for a press conference to send the message to "slow down" and to let the community know that our police will enforce traffic and speed laws. "Slow Down Sandy" - you will hear that message a lot this summer. Mayor Z recently attended the Utah Peace Officers event. The Governor's 20 Award was given to our Police Chief, Greg Severson and she congratulated him on this achievement. June marks Pride Month and mentioned that all are welcome in Sandy. The new pickleball courts opened in Sandy City. The Central Wasatch Commission launched an environmental dashboard on the website.

CAO Report

Cliff Strachan, CAO, mentioned that next week, Administration is scheduled to present an overview of the city-wide capital projects to the Council. The spring bulk waste clean up effort has wrapped up and was successful. The Mayor and CAO watched an active shooter training today and was very proud of our police force. At the July 12th City Council meeting there will be a tour with the Council and Planning Commission. The iCanTriatholon will be held on Saturday, June 18th.
