Council Chair Stroud invited the public to participate in General Citizen Comments.

Mr. Bruce Blanchard agreed with Council Member Sharkey's proposal regarding the installation of campaign signs following a candidate's election filing. He spoke about the state's consideration of the elimination of property taxes which he feels will disproportionately impacts lower income individuals. He expressed support of Jim Edwards to serve as an alternate to the Planning Commission. He spoke of his friend, Mr. Paul Pratt, who recently moved out of Sandy City. Mr. Blanchard thanked the elected officials for the many hours of service they provide to this great community of Sandy City.

Ms. Dawn Sidwell expressed concerns regarding the proposed amendments to the Pledge of Fair Campaign Practices considered in Item 2 on the Agenda. She feels it is her first amendment right to have the ability to put up signs on her private property.

Mr. Aaron De Keyser believes in private property rights and is not supportive of the amendments to the pledge which will be introduced in Item 2 on the Agenda. He expressed support for Mr. Jim Edwards appointment to the Planning Commission.

Ms. Anita Bennet has lived in Sandy for 40 years and appreciates all the hard work of the Council Members and City staff. She expressed support for Jim Edwards appointment to the Planning Commission. Mr. Edwards is a hard working, fair, and honest person.

Ms. Susan Richardson is supportive of Jim Edwards appointment to the Planning Commission. She trusts him and thinks he is of good character.

Mr. Steve Van Maren is supportive of Jim Edwards appointment to the Planning Commission.

At the request of Council Member Sharkey, the Council Director read an eComment into the record sent in by Ms. Katie Johnson. She thinks the City should be careful before making any changes during an election year and she spoke about her First Amendment rights.
