Agenda Planning Calendar Review

Chairman Stephen Smith reviewed upcoming items on the Agenda Calendar.

Council Member Business

Scott Cowdell addressed the transfers between the Water Fund and the General Fund that occurred back in 2011. He felt the Council acted responsibly on this action. This prevented people from losing jobs during a downturn in the economy. He believes the Council stepped up and did what needed to be done at the time.

Scott Cowdell also addressed homeless shelters, and asked if Sandy had a location to accommodate the homeless. Chris McCandless expressed interest in speaking with Scott regarding this issue.

Scott Cowdell addressed the proposed paved trail in Dimple Dell Park, and would like the Council to hold a discussion in the near future to determine if the Council supports the trail.

Stephen Smith noted that he has talked with Monica Zoltanski, Chair Dimple Dell Preservation Community. The Council is waiting to gather information on a community poll.

Council Office Director's Report

Michael Applegarth noted that the new analyst will start tomorrow. His name is Dustin Fratto. He will be introduced to the Council formally during next week's Council meeting.

Mayor's Report

No report was given.

CAO Report

Chief Thacker reported that the Police Department, through salary savings, would like to purchase four new vehicles prior to the end of this fiscal year budget.

Scott Bond reported on the damage that occurred to trees and personal properties from

the storm this past weekend.

Scott Earl reported that several trees were damaged in parks and neighborhoods from the past weekend storm. Public Works offered support in helping to clean up broken limbs and branches.

Mike Gladbach reported on clean-up from the storm. They are in the process of the annual Spring clean-up, and the storm has added an additional burden on his crew members. They will need to work overtime on Saturday to stay on schedule.

Scott Bond passed out copies of the Cairns master plan from the Community Development Department.

Scott Bond announced that Mayor Tom Dolan will be recognized as Best of State for Mayor.

Information Items

2. [17-089](#) Public Works Department introducing new Transportation Engineer Brittany Ward.

Mike Gladbach introduced Brittney Ward as the City's new Transportation Engineer. She graduated from the University of Utah, and worked for Provo City for five years.

Steve Smith asked if Ms. Ward had been briefed on the new 13th East bridge, and the safety concerns that have been expressed by the residents.

Brittney Ward noted that she had been briefed on this issue.

Mike Gladbach noted that the bridge project was not complete. Timing studies along with additional education on drop off locations will take place.

Steve Smith noted that discussions have been held with school officials regarding the closure of the upper parking lot.

Kris Nicholl noted that the Canyon's District would be willing to advertise and talk with parents and students on how to best utilize the bridge.

Maren Barker felt this issue may need to be addressed further even with the new implementations.

Chris McCandless noted that it would be up to the School District to determine if closing the upper parking lot would be beneficial in helping resolve traffic and pedestrian concerns during drop off hours at the school.

Mike Applegarth briefed the Council on the process Payson City used to enact a local sales and use tax to help fund Parks, Arts, Recreation, and Culture facilities (PARC).

5. [17-041](#) Council Member Barker recommending the City Council consider invocation of the pending ordinance doctrine amending the Land Development Code to limit Planned Unit Developments to parcels larger than five acres in size, or other alternatives improving the use of PUDs as a development tool.

Maren Barker would like the Council to address the use of PUD's in the city, and determine options they would feel comfortable with. The proposal is to eliminate PUD's on properties that are five acres or less.

Chris McCandless was concerned that eliminating PUD's on parcels five acres or less would diminish and restrict opportunities for blighted properties in the City.

Scott Cowdell felt strongly that property owner's rights should be protected.

Stephen Smith stated that there are compromises with a PUD designation. He feels that PUD developments are not held to the same standards as other developments.

Maren Barker noted that she would meet with James Sorensen to discuss other options and possibilities for a future discussion.
