Dustin Fratto, Executive Director: Next week we will be taking the Council photo following the meeting. The new director for WFWRD will present to the Council. The Council and staff will participate in required data privacy training next week. He also updated the Council on upcoming agenda items.

Council Member Business

Council Member Kris Nicholl thanked all who attended the Oath of Office Ceremony and also thanked staff for coordinating the event. It was an awesome event. It felt like a family event.

Council Member Marci Houseman expressed appreciation to all who attended and organized the Oath of Office Ceremony for the incoming Council Members. She was thrilled to work with the new council members. She hoped the Council would again participate in a budget priorities workshop later this month or next. She spoke about the One Word Challenge and asked the Council if they would like to pick a word to guide them during 2026.

Council Member Brooke Christensen thanked all who supported her re-election to the Council. She was excited to return to the Council and represent District 1.
