WHEREAS, the agency shall obtain permission to apply the property to a public interest use and the designation and approval of the public interest use of the property from the agency's legislative body.

NOW, THEREFORE, BE IT RESOVED, by the City Council of Sandy City, Utah:

- 1. The Sandy City Police Department has complied with the requirements in Utah Code, Title 77, Chapter 24a, Section 5 and no claim has been made for the property shown in **Exhibit "A"**.
- 2. The attached request (**Exhibit "A"**) for interdepartmental transfer of property from the evidence room is approved and this resolution is effective upon adoption.
