Melissa Anderson introduced this item to the Planning Commission.

Darien Alcorn said there is a definition of what constitutes public landscaping.

Melissa Anderson said yes and it's in the packet.

Jamie Tsandes clarified that they were still talking about bonding.

Melissa Anderson said yes and offered solutions.

Dave Bromley asked what this does to existing bonds.

Melissa Anderson said that it will be effective for anything going forward after this is adopted and not retroactive.

Jamie Tsandes asked for more clarification regarding bonding for street trees.

Melissa Anderson explained that the State law stipulates the City is not allowed to bond for street trees that are located behind the sidewalk on private property. Alternatively, the City can bond for street trees in the public-way, that are dedicated and maintained by the City.

Dave Bromley asked if a road system within a private development would get bonded.

Melissa Anderson said yes.

Cameron Duncan spoke about trees within the park strip.

Daniel Schoenfeld opened this item for public comment.

Daniel Schoenfeld closed this item to public comment.

Jamie Tsandes asked about the section that talks about engineer requirements and if the requirements are at their own discretion or do they have a list to follow.

Ryan Kump, Sandy City Engineer, replied that as long as it's compliant with state law and it's essential to development then he can ask to bond for it.

A motion was made by Cameron Duncan, seconded by Dave Bromley that the Planning Commission forward a positive recommendation to the City Council to amend Title 21, of the Sandy Municipal Code, relating to improvement completion guarantees (bonding) as shown in Exhibit "A", based on the findings in the staff report and with the following amendments:

- Correct the scrivener's error by replacing the reference to Section 12-2-16 to Section 21-2-16.
- 2. For consistency, replace "Planning Division" and "Planning Staff" with

"Community Development Department."

3. Relocate the last sentence under Sec. 21-13-7(a) "On-Site Trees and Shrubs" to the paragraph that follows under Sec. 21-13-7(b) "Street Trees."

Jeff Larsen with Larsen Design Group spoke explained the articulation of the building and the site.

David Hart asked what the use is on the west side of the building.

Jeff Larsen replied that it is an access to an exterior generator that is fenced in and landscaped with one dog run.

Coleman Gregor with Larsen design group explained that the dog run wont be a play area but just to make sure dogs are able to walk.

Jamie Tsandes asked about the landscaping and if it meets code without sod.

Doug Wheelwright said yes.

Mike Wilcox clarified that if the park strip isn't 8' it cannot be sod and will need to be changed.

Doug Wheelwright explained the architecture meeting and that the building meets the design standards and recommends its approved as proposed.

Daniel Schoenfeld asked if the applicants are comfortable with staff report.

Kathy James said yes.

Steve Van Maren, 11039 S Lexington Circle, Sandy, asked about having working windows on the south and west sides of the building.

Daniel Schoenfeld closed this item to public comment.

Doug Wheelwright explained the windows and that it is back of house and some of the equipment stops them from having functional windows on those sides.

Cameron Duncan asked about electrical boxes and screening.

Doug Wheelwright said it is required and part of the final review with staff.

A motion was made by David Hart, seconded by Jamie Tsandes, that the Planning Commission determine that Preliminary Commercial Site Plan Review is complete for the VEG Animal Hospital project, located at 11084 S State St., and also to approve the proposed building architecture, materials and colors as now proposed by the applicant, based on the two findings and subject to the four conditions detailed in the staff report with a 5th condition added that the

landscaping plan meets the water wise ordinance if applicable.

Staff Note - After the meeting, it was determined that this application was made prior to the recent Waterwise Landscaping code amendments referenced in the discussion and motion went into effect. Therefore the new amendments will not apply to this project.
