Supplemental Indenture

Brian Kelley, Finance Director, presented Resolution 23-44C for Council consideration and action. The resolution authorizes the issuance and sale of Sales Tax Revenue Bonds in the aggregate principal amount of not to exceed \$10,000,000. The Series 2023 Bonds shall mature in not more than fifteen years and shall bear interest at a rate of not to exceed five and one-half percent. The funds will be used for the Monroe Street extension. Engineering has begun the design process. Ryan Kump with Public Works mentioned the possibility of a funding shortfall of approximately \$700,000. The department is working to mitigate the shortfall through design engineering. Council questions and discussion followed.

Departmental Management Studies Policy

Dustin Fratto, Council Director, reviewed the Request for Proposal for a General Management and Operations Study of the Sandy City Fire Department. The Council Meeting will begin at 6:30 pm with a presentation of the 2022 Noal Bateman Lifetime Service Award presented to Scott Bond in recognition of his service and significant impact on Sandy City and the community.

### Council Member Business

Council Member Zach Robinson thanked Shane Pace, CAO and Mayor Zoltanski and the department heads for their responsiveness and for coordinating all the public engagement. He appreciated everyone's efforts.

Council Member Scott Earl thanked Parks & Recreation for installing a bench on the canal trail in response to a resident's request.

Council Member Alison Stroud thanked the Public Utilities teams for their quick response to help a resident with their issue. She also expressed appreciation to James Sorenson for his responsiveness.
