## **ORDINANCE # 24-04**

AN ORDINANCE AMENDING THE SANDY CITY GENERAL PLAN BY ADOPTING AN UPDATE TO THE PARKS, TRAILS AND RECREATION MASTER PLAN; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City has the authority pursuant to Sections 10-9a-401 et seq., <u>Utah Code Ann.</u> 1953, as amended, to make, adopt, amend, extend and add to a general plan for the physical development of the municipality; and

WHEREAS, the Sandy City Parks and Recreation Department has requested to review a proposed amendment to the Sandy City General Plan by adopting the Parks, Trails and Recreation Master Plan; and

WHEREAS, the Planning Commission has reviewed the amendment to the Sandy City General Plan at a public hearing held on March 7, 2024, notice of which hearing was posted in Sandy City Hall, Sandy Parks & Recreation, the Salt Lake County Library-Sandy, the Sandy City Website - http://www.sandy.utah.gov, and the Utah Public Notice Website - http://pmn.utah.gov on February 22, 2024, and mailed to affected entities on February 21, 2024, and forwarded the Plan, with a positive recommendation, to the City Council; and

WHEREAS, the Sandy City Council has held a public meeting before its own body on March 12, 2024 and March 19, 2024 to discuss the amendment to the Sandy City General Plan, and has taken into consideration citizen testimony, planning data, the interested parties information and comments about the proposed amendment and the Planning Commission recommendation as part of the Council's deliberations; and

WHEREAS, the City Council has determined that it would be in the best interests and promote the welfare of the City and its residents by amending the City's General Plan by adopting the proposed Parks, Trails and Recreation Master Plan.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Sandy City as follows:

- Section 1. The Sandy City General Plan is hereby amended by adopting the Sandy City Parks, Trails and Recreation Master Plan, as set forth in **Exhibit "A"**. Such update to the City's General Plan is attached to this ordinance and made a part hereof.
- Section 2. All former ordinances or parts thereof conflicting or inconsistent with the provisions of this ordinance or of the Code hereby adopted are hereby repealed.
- Section 3. The provisions of this ordinance shall be severable; and if any provision thereof, or the application of such provision under any circumstances is held invalid, it shall not

affect any other provision of this ordinance, or the application in a different circumstance.

Section 4. This ordinance shall become effective upon the publication of a summary thereof.
