

## *RESOLUTION #23-42 C*

A RESOLUTION ADOPTING THE ANNUAL BUDGET IN THE ALTA CANYON SPORTS CENTER FOR THE FISCAL YEAR COMMENCING JULY 1, 2023 AND ENDING JUNE 30, 2024; ALSO ESTABLISHING CERTAIN FEES AND CHARGES FOR SAID FISCAL YEAR.

WHEREAS, on May 2, 2023, the City Council of Sandy City received the mayor's tentative budget for each fund of the City, as provided in Utah Code Section 10-6-111; and

WHEREAS, on May 2, 2023, the City Council adopted, by Resolution #23-15 C, the tentative budget for the coming fiscal year, for purposes of further review, and set a public hearing for May 30, 2023 to consider final adoption of the budget; and

WHEREAS, at least seven days notice of said public hearing was published on the Sandy City website home page, the Utah Public Notice Website, and in three public locations, with Utah Code Section 10-6-113; and

WHEREAS, on June 20, 2023 the City Council adopted, by Resolution #23-24 C, the certified tax rate for the Alta Canyon Recreation District set by Salt Lake County; and

WHEREAS, on June 20, 2023 the City Council adopted, by Resolution #23-23 C, a proposed property tax rate for Sandy City, and set a public hearing for August 22, 2023 in compliance with Utah Code Section 59-2-919 through 59-2-923; and

WHEREAS, due to the proposed property tax increase, final adoption of the Sandy City budget is delayed until said public hearing is complete, and budget changes could impact the Alta Canyon Sports Center budget; and

WHEREAS, each tentative budget and all supporting schedules and data have been held as a public record in the office of the City Recorder, available for public inspection for a period of at least 10 days prior to the date of this resolution; and

WHEREAS, from May 30, 2023 through June 20, 2023, and on August 22, 2023, public hearings were held on adoption of said budget and to consider a property tax increase, at which time all interested persons in attendance were given the opportunity to be heard, for or against, the estimates of revenue and expenditures of any item in the tentative budget of any fund; and

WHEREAS, Section 10-6-133(1) in Utah Code Annotated 1953, requires that, at a regularly scheduled meeting, the City Council set a proposed property tax rate before the 22<sup>nd</sup> day of June of each year; or, in the case of a property tax increase before September 1<sup>st</sup> of that year.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Sandy City, Utah, as follows:

BUDGET ADOPTION

1. Budgets for the Alta Canyon Sports Center, as presented, are hereby adopted for use by Sandy City for the fiscal year 2023-2024.
2. The particular budgets, amounts thereof, and supporting schedules are attached to this resolution and specifically incorporated herein and made a part hereof.

FEE SCHEDULE ADOPTION

3. The fee schedule set forth in the budget is hereby adopted and shall be in effect during the fiscal year 2023-2024. These fees shall not be waived or deferred except as provided by law or by resolution of the City Council.
