Subject: Council Members Robinson and Stroud proposed amendments to the FY 2023

Tentative Budget

Description

The intent of this amendment is to outline the proposal to increase the appropriations in the FY2023 budget to fund 2 additional full-time firefighters including their associated equipment costs and to fund 3 sets of cordless extrication equipment (As displayed in Fire-ops 101) for the Fire Department. These expenditures were not included in the FY2023 Tentative Budget and will necessitate the following increases:

2 additional Firefighter FTE Salary & Benefits (for a total of 3 FTE's): \$171,454 (Exhibit A)

Uniforms & Equipment: \$16,000 (Exhibit B)

Training: \$4,000 (Exhibit B)

Extrication Equipment: \$131,199 (Exhibit B)

Total: \$322,653

In order to fund these expenditures, it is proposed that new projected revenue is appropriated to cover the ongoing expenditures and to fund the one-time expenditures previously allocated contributions to the Capital Contingency line item will be reallocated to the Fire Equipment line item in the FY23 equipment management fund. Any cleanup, due to these changes within department 2200, will be added or subtracted from the fleet purchases line item within that department (For the Fire Pumper).

The potential ongoing revenue sources are the same sources as was presented by finance staff regarding the bulk waste fee issue. Namely increased projections to sales tax, RDA revenue, road funds and park reservation funds. Other reductions in expenses may also be considered as well.
