To Whom It May Concern,

Our community is being greatly affected by the closure of Kuwahara's Greenhouses and Farmers Market.

We realize that the Sandy City Planning Board has the best intentions toward serving our community. With this in mind, we reasoned that the Planning Board may not have all the information about Kuwahara's Greenhouse & Farmers Market and the great needs it fulfills.

Last summer, Kuwahara's reached out to support many individuals and groups. To name just a few of the activities and generosities of this family and their family owned small business, I will begin with what I have witnessed firsthand.

Early in the spring before opening, I approached the family to find out if they were going to allow local artists to sell their products with them, through them or lease booth space. Wheeler Farm, Gardner Village and the All City Center all try to work with the local farmers, artists and entrepreneurs. Kuwahara's has always used local growers and artisans. They said they would love to work with the local artists anyway they could but were unable to set up booths. In this they made space for arts and crafts inside their little sales area, exhibiting it on consignment with no charge. Creating these partnerships brought hope to many struggling homes and entrepreneurs.

During this conversation, we discussed their dream of helping "special needs" individuals and groups. Creating a partnership with Changing Faces and Daylilly Arts, we were able to create new ways to get involved. Our face painters were given space, without charge, to learn the methods and skills of this craft. The artists were either handicapped themselves, elderly or had special needs children in their home that they were financially responsible for. Any funding the artists made, they kept. Many are now able to help subsidies their families income.

Daylilly Arts has worked with multi-level, multi-cultural, and multi-populace students and families in Utah, Idaho and Wyoming since 1999. Kuwahara's extended a partnership providing a space for art classes, and other activities, <u>for free</u>, to our Autistic and Downs Syndrome children and adults. This was a very beautiful and inspiring location for socialization for our students. They also provided healthy treats, instruction in gardening and growing flowers, recycling, and conservation. And don't forget, acceptance and love.

With this partnership, we were also able to create and offer Parent/Child classes called "Fairy Gardens". These classes gave families quality time often missed out on in our daily lives. This included talking about plants and their care, creating fun fairy "things" such as chairs,

clotheslines, huts and houses using the principles of recycling and reuse for discarded objects. Teaching simple methods of recycling and creating compose to help keep garbage out of our city dumps was discussed in all classes.

I observed their generosity to the local families. As the fruits ripened, daily they were rotated with only the best kept for sale. Maintaining the highest quality is their imperative. The fruits and vegetables beginning to get ripe were then given to families in the neighborhood. One special needs individual came in several times a week for food. They always sent him home with bags packed full. Other families were given fruits and vegetables for canning. Once a week they also provided "FREE barbecued corn" day.

Many opportunities of giving is/was also done with the actual vegetable plants, and flower plants, too. Teaching and sharing their knowledge are just as important as the sale. Making sure the consumer was getting the right plant for their needs and conditions was part of every conversation and sale. This positive respect for life is evident in all their dealings. Partnering with Clever Octopus, they also provided 3 flowering plants, soil and containers for The Promise Group (South Salt Lake Refugee Center), a total of 63 children, to create "fairy gardens" to take home. This also included information on recycle, reuse, and taking care of our environment.

Over the past 5 years, I have been able to witness the improvements to the property and steady growth. It has been a place of social gathering where the high end and well educated mingle easily with others who live on meager means. Families take their children and friends just to see the flowers and hang out.

Kuwahara's provides fresh vegetables and healthy foods to our neighborhood, that is within walking distance of our individual homes, apartment complexes and other businesses. This is not fast food, or heavily preserved packaged products sold at the convenience stores and restaurants. Removing Kuwahara's creates a "food desert" for our local residents. This business is an agricultural business that brings beauty to our neighborhood through the flowers and plants exhibited and sold, fresh vegetables and plants and real education that pertains to our local growing area enabling their customers to be successful at growing their own fresh food.*

Sandy has changed. Not all of the changes have been for the betterment of the elderly, and those of lower income and homeowners. Our community is losing the wildlife we have grown up with including the squirrels, ducks, quail and geese to name a few. We are having apartment complexes, asphalt and businesses forced down our throats.

The larger stores and big box chains do not provide the opportunities that Kuwahara's does. Draper, Cottonwood Heights, Murray and South Jordan are but a few of the cities that have local farmers markets. Ours is better! Ours is a true AGRICULTURAL jewel!

In speaking with many of our neighbors, we are wondering why you are making this so difficult for Kuwahara's to stay in business? Why are you creating so many obstacles, that will make them fail? Are you forcing them to financially fail on purpose? What is your real goal? What do you gain from this? Daily we have realtors knocking on our doors trying to buy up the older homes to put several new homes in our place.

WE KNOW WHAT WE ARE LOSING. What will our community gain from their loss?

The quality of life we are now experiencing has been changed for the worst with every "improvement" Sandy City thinks we should just take without complaints. Our water is a mess. Trax has brought transients and their problems to our neighborhoods. Theft and vandalism have skyrocketed, reporting it, we get the same results – none. (That is not due to our police force, we love them.) Our little parks that are in our neighborhood are filled with drugs and transients. (Kuwahara's was a safe place for our kids!) The traffic is unbelievable and that's on a good day. Try to go anywhere on a game day or park on your own street. And that's just a start! We need someone to help us!

Please do not drive away a business that we love and need, that brings positivity and goodness.
