

## ORDINANCE # 20-15

AN ORDINANCE AMENDING THE SANDY CITY GENERAL PLAN BY THE ADDITION OF AN ACTIVE TRANSPORTATION PLAN; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City has the authority pursuant to Sections 10-9a-401 et seq., Utah Code Ann. 1953, as amended, to make, adopt, amend, extend and add to a general plan for the physical development of the municipality; and

WHEREAS, the 2019-2050 Regional Transportation Plan identifies active transportation as a significant component in meeting the goals of the Wasatch Choice 2050 Vision; and

WHEREAS, the Planning Commission has reviewed the amendment to the Sandy City General Plan at a public hearing held on November 19, 2019, notice of which hearing was posted in Sandy City Hall, Sandy Parks & Recreation, the Salt Lake County Library-Sandy, the Sandy City Website - <http://www.sandy.utah.gov>, and the Utah Public Notice Website - <http://pmn.utah.gov> on November 4, 2020, and published in the Salt Lake Tribune on November 4, 2020, and forwarded the Plan, with a positive recommendation, to the City Council; and

WHEREAS, the Sandy City Council has held a public meeting before its own body on December 8, 2020 to discuss the amendment to the Sandy City General Plan, and has taken into consideration citizen testimony, planning data, the interested parties information and comments about the proposed amendment and the Planning Commission recommendation as part of the Council's deliberations; and

WHEREAS, the City Council has determined that it would be in the best interests and promote the welfare of the City and its residents by amending the City's General Plan by adding the housing related changes.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Sandy City as follows:

Section 1. The Sandy City General Plan is hereby amended by accepting the Sandy City Active Transportation Plan, as set forth in **Exhibit "A"**. Such update to the City's General Plan is attached to this ordinance and made a part hereof.

Section 2. All former ordinances or parts thereof conflicting or inconsistent with the provisions of this ordinance or of the Code hereby adopted are hereby repealed.

Section 3. The provisions of this ordinance shall be severable; and if any provision thereof, or the application of such provision under any circumstances is held invalid, it shall not affect any other provision of this ordinance, or the application in a different circumstance.

Section 4. This ordinance shall become effective upon the publication of a summary thereof.
