#### **City Council Objectives**

Allow brewpubs beyond the *Cairns District*Lower regulatory and financial barriers to entry

Streamline permitting and licensing processes

Align City Code with Utah Code



#### INTENT FOR BREWPUBS IN SANDY



**Brewpub** is intended for a restaurant with brewery that sells beer and heavy beer for on-site consumption.



#### **OBJECTIVE**

Consider allowing brewpubs beyond the downtown Cairns District

#### Title 21, Land Development Code Changes


- Chapter 21-8, Permitted Land Uses in the Commercial, Office, Industrial, ... Districts
- Chapter 21-19, Special Development Zones
- Section 21-23-16, Alcoholic Beverage Distance Requirements
- Section 21-37-2, "A" Definitions



#### UTAH LICENSING REQUIREMENTS

- Brewpub requires two licenses from DABS:
  - 1. Manufacturing brewery license
  - 2. Restaurant license to serve alcohol (A minimum of 70% food sales is required)
- May NOT locate within proximity of Community Locations:
  - Public or private schools
  - Churches
  - Public libraries
  - Public playgrounds
  - Public parks


#### LAND USE & LICENSING REQUIREMENT

A Brewpub is enabled as a land use by allowing a *Manufacturing Brewery License* in a zone, if it is on the same premises as a Restaurant.



#### PROPOSED BREWPUB CODE AMENDMENTS

- Allow brewpubs in zones that currently allow restaurants to serve alcohol
  - Commercial, mixed use, office, industrial and special development commercial districts
- If a restaurant that serves alcohol is a permitted use in the zone, then a brewpub would be a permitted use (Same approach for Conditional Uses)



#### CITY AND STATE CODE CONSISTENCY

- Terms and definitions are updated with current Utah Code (Title 32B)
- SD-JHS MILLER zone (9400 S State St)
  made consistent with other Cairns
  District zones that allow alcoholic
  beverage license related uses
- SD-MU Mixed Use Zone (7800 S 1300 E) removes non-conformity for an existing restaurant that is licensed to serve alcohol by updating the land uses



## PLANNING COMMISSION RECOMMENDATION

Forwarded a positive recommendation to the City Council to amend Title 21, of the Sandy Municipal Code, related to Brewpubs based on the analysis and findings in the staff report.






## TITLE 15 - BUSINESS LICENSING CHAPTER 2 - ALCOHOLIC BEVERAGE REGULATIONS

Terms and definitions are updated with current Utah Code (Title 32B)

- "Dept. of Alcoholic Beverage Control" changed to the "Dept. of Alcoholic Beverage Services" (DABS)
- "Club" licenses replaced with "Bar Establishment" licenses





#### Sandy City Business License Certificate State of Utah

### Streamlining and Reducing Costs

- Bonding requirements are removed.
- One application is required (vs. two) for a restaurant that serves alcohol with a brewery manufacturing license.



## TITLE 15 - BUSINESS LICENSING & ALCOHOLIC BEVERAGE REGULATIONS



- Clarified the differences between approvals, denials and revocations of applications and licenses.
- Clarified that if there's conflict between Utah Code and Sandy Code relating to hours of sale and consumption, the stricter prevails.
