Council Member Business

Council Member Zach Robinson acknowledeged Leslie in Animal Services for her efforts to help a Sandy resident. He is working on coordinating a town hall event for Alta Canyon Recreation Center for May 8th. All are invited.

Council Member Cyndi Sharkey acknowledged the public works staff and all they do for our city - snow plowing, bulk waste clean up. They are doing an awesome job!

Council Member Alison Stroud updated the Council on the flag design committee. More feedback will be gathered from residents on design option A. She also provided an update from the recent National League of Cities and Towns conference she attended in Washington DC. She and Council Member D'Sosa met with our lobbyist, Bill Simmons and Representative Curtis and Owens regarding issues our city is facing. It was an extremely beneficial meeting.

Council Member D'Sousa echo'd Ms. Stroud's comments. The conference was a great way to interact and connect with our federal representatives. Sandy Youth Council applications are available on the website. The SYC is open to all high school age youth in 9th through 12th grades.

Mayor's Report

Mayor Zoltanski thanked Council Member D'Sousa and Stroud for meeting with our Federal Representatives in Washington DC while they were at the conference. She acknowledged the Public Works crews for all their hard work over this past winter and she thanked the police officers for their work at Little Cottonwood Canyon. On May 1st the City will hold a town hall event to discuss flood mitigation and preparation. All are encouraged to attend.

CAO Report

Shane Pace, CAO spoke about the city's response and flood preparation. He spoke about the communication and outreach to residents. He also provided an update on the city's efforts to repair the potholes on city streets.
