NOTICE IS HEREBY GIVEN that on November 7, 2024, at approximately 6:15 pm in a hybrid (in-person and virtually) meeting, in accordance with Utah Code 52-4-207(4) Open and Public Meeting Act the Sandy City Planning Commission will hold a public meeting regarding annexing a certain contiguous unincorporated area, totaling approximately 0.64 acres, located at 8411 S. 1475 E. and 1491 E. 8425 S. in Salt Lake County, Utah. It is being proposed to annex these properties into the City with the R-1-10 zone. The Planning Commission will be conducted both in-person, in the Sandy City Council Chambers at City Hall (10000 S. Centennial Parkway), and via Zoom Webinar. Citizens wishing to comment virtually on the proposed annexation must access the meeting via the Zoom Webinar link, which will be included on the November 7th meeting agenda. 

The November 12th Sandy City Council meeting will be conducted in-person and virtually, via Zoom Webinar. Citizens wishing to comment virtually on the proposed annexation must access the meeting via the Zoom Webinar link, which will be included on the November 12th meeting agenda.
