Eric Richards, Communications Director, provided the Council a review and update on the Sandy City Communications over the last decade. Under his leadership and direction the Communications Department has achieved many milestones: over 46,500 followers on social channels, and over 107,000 subscribers to our notifications. The city migrated to a new website platform in 2020 which includes web accessibility enhancements and greater connectivity for our residents. Citizen Connect, Sandy Notify, City Serve and Chatbot are all new features introduced over the last decade creating engaging and informative resources for our residents. Kasey Dunlavy, Economic Development Director provided to the Council an update of the Cairns Development. The Cairns Vision includes twenty million square feet of development and includes the East Village, One Ten Apartments, Shops at South Town, RedSky apartments, the Summit at the Cairns, Mountain America Arts & Education Beehive Education Center, Sandy Park Center, Phase 6 of Monroe Street Extension, Wasatch Shadows, and Town Ridge Center. He reviewed key market takeaways. The Office markets have been weakening since mid-2022. The Retail market is contending with inflation, high gas and food prices, and rising credit card debt. Multifamily new constructions has faced significant challenges with surging financing costs. Council questions followed. Council thanked Mr. Dunlavy for his presentation. Council expressed support for Economic Development and is willing to help in any way.
