CORRIDOR PRESERVATION AGREEMENT

AN INTERLOCAL AGREEMENT

AMENDMENT 01

THIS AMENDMENT NO 01 TO COOPERATIVE COORIDOR PRESERVATION AGREEMENT, made and entered into on the ____ Day of _____2018, by and between UTAH DEPARTMENT OF TRANSPORATION, hereinafter referred to as “**UDOT**” and **SANDY CITY CORPORATION**, a Municipal Corporation of the State of Utah, hereinafter referred to as “**City**”.

NOW THEREFORE, it is agreed by and between the parties hereto as follows:

(1) Amend paragraph no. (1) as follows:

To facilitate traffic flow along the SR-209 (9000 South) corridor between 700 West and Wasatch Boulevard, the following locations are identified as locations for existing or future traffic signal installation:

SR-209 at Riverside Drive (700 West)	(Existing Signal)
SR-209 at Sandy Parkway (450 West)	(Existing Signal)
SR-209 at I-15	(Existing Signal)
SR-209 at Monroe Street (150 West)	(Existing Signal)
SR-209 at US-89 (State Street)	(Existing Signal)
SR-209 at 150 East	(Existing Signal)
SR-209 at 300 East	(Existing Signal)
SR-209 at SR-71 (700 East)	(Existing Signal)
SR-209 at 9100 South	(Existing Signal)
SR-209 at 9400 South	(Existing Signal)
SR-209 at 1300 East	(Existing Signal)

(2) Amend paragraph no. (5) as follows:

In order to promote safety and efficiency within the SR-209 corridor, unsignalized access on to SR-209 (between 600 E. and 700 E.) will be limited to shared right-in –right-out per UDOT’s access management requirements (Administrative Rule R930-6). Access will be limited by the use of a raised median island.

(3) Delete paragraph (8)

(4) Amend paragraph no. (10) as follows:

The duration of this Agreement shall continue until cancelled by either party hereto. All other terms and conditions of this agreement remain in effect.
