Steve Van Maren expressed concern about increasing the cost of service and thought the savings should be returned to residents.

Jim Edwards was interested in how the savings calculation was obtained. He recommended that residents be allowed to opt-out of recycling, and that savings should be returned to residents. The education campaign should be focused on the can itself.
