

## RESOLUTION #22-43 C

A RESOLUTION INCREASING TOTAL APPROPRIATIONS WITHIN THE GOVERNMENTAL FUNDS FOR THE FISCAL YEAR COMMENCING JULY 1, 2022 AND ENDING JUNE 30, 2023, AND PROVIDING FOR THE PURSUIT OF SPONSORSHIPS AND THE SALE OF NAMING RIGHTS FOR THE ALTA CANYON SPORTS CENTER, AND CONFIRMING SANDY CITY'S INTENTION TO PLEDGE UP TO \$20,000,000 TOWARDS THE FUTURE CONSTRUCTION OF THE ALTA CANYON SPORTS CENTER AND CONFIRMING SANDY CITY'S INTENTION TO FULLY FUND THE REPLACEMENT OF FIRE STATION 31.

**BE IT RESOLVED** by the City Council of Sandy City, State of Utah, that the amounts described in the Exhibits A-C be adjusted as outlined. These adjustments are made pursuant to the provisions of Sections 10-6-127 and 10-6-128 U.C.A. as amended, and are done with the provision that no appropriation for debt retirement and interest, reduction of deficit or other appropriation required by law or ordinance is reduced by this resolution; and

**BE IT FURTHER RESOLVED** that the city council hereby authorizes and directs the administration to take all steps necessary to pursue funding from intergovernmental partnerships, private sponsorships, other private sector partnerships and for the naming rights associated with the Alta Canyon Sports Center and to bring back a parameter's resolution before the council, if and when such resolution becomes necessary; and

**BE IT FURTHER RESOLVED** that Sandy City intends to pledge up to \$20,000,000.00 towards the construction of a rebuilt or remodeled Alta Canyon Sports Center in addition to any funding raised through intergovernmental partnerships, naming rights and sponsorships; and

**BE IT FURTHER RESOLVED** that Sandy City intends to fully fund the replacement of Fire Station 31.
