The challenge of growth.

Utah is growing. By 2050, our population will have almost doubled. How do we ensure that our children can stay in Utah and live in communities with good quality of life? Even though Utah is growing rapidly, with the right decisions we can still keep this a great place to live.

HOW DO WE ENSURE GOOD DESIGN AND QUALITY OF LIFE?

HUMAN-SCALE DESIGN

Like old town centers, it should be easy and pleasant to walk from building to building and place to place. This is helped by wide sidewalks, lots of windows, parking behind buildings with entrances on the street, and a good mix of uses. Other amenities such as benches, planters, and trees also make a place feel like it's meant for humans, not just cars.


ACCESS TO RECREATION



REASONABLE PARKING


Business parking standards are often designed to meet the "busiest day of the Christmas season" standard. Newer more reasonable standards exist. In well located and designed centers, people come by means other than car. This helps further reduce the need for parking. The best place for parking is underground, in well designed structures, or behind the building.

CONNECTED NETWORKS



HOW DO WE PLAN FOR SCHOOLS, CHURCHES, AND LONG-TERM DEMOGRAPHICS?

A MIX OF HOUSING so that communities can be successful over time. Communities should not be designed for only one demographic at a time. Housing should cater to a range of ages and lifestyles. This ensures that different generations can live in the same area and children can live, grow, and possibly stay in the same communities where they are raised.



ALLOW PEOPLE TO AGE IN PLACE. With a good mix of housing it is possible for residents to remain in their communities as they age.

MAKE COMMUNITIES THAT ARE DESIGNED FOR MANY GENERATIONS. Churches and schools shouldn't be built for one generation then made obsolete. This requires collaboration between school districts, churches, cities, and developers to keep them all on the same page.

HOW DO WE MAINTAIN FISCAL SUSTAINABILITY FOR OUR CITIES AND TOWNS?

COMPACT GROWTH helps to lower costs per household because infrastructure doesn't have to stretch as far to get to each home or business. More compact growth also increases the tax revenue per acre. In addition, more households in a given area create a strong base to support local retail and office supply.

INFILL development utilizes existing buildings and infrastructure, which helps keep overall development costs down. Infill also helps centers by preserving and revitalizing existing communities. Both of these strategies alleviate the pressure on farmland to develop by using urban land more efficiently.

Having a range of centers at different scales allows communities to incorporate all the destinations and services that people need to access. The size, location, and components of these centers vary and are determined by market needs, with different types of businesses and public services requiring different sizes of market areas.



HOW DO WE IMPROVE CONVENIENT ACCESS TO JOBS, SERVICES, AND HOUSING?

CONNECTED STREET NETWORKS.

A well connected street network allows safe and convenient travel for pedestrians and cyclists and also reduces the total number of vehicle miles traveled by creating more direct paths. Connected street networks also take pressure off major routes by giving drivers efficient alternate paths that can also be used in case of emergencies that close primary routes.



COMPLETE STREETS.

Complete streets are designed to accomodate multiple modes of transportation in a way that is appropriate to the area. A complete street may include sidewalks, bike paths, bus lanes, medians, and numerous crosswalks



MIX OF USES. Mixing uses means there will be a greater variety of jobs, services, and amenities in close proximity to where people live. This means people can take fewer, shorter trips, and potentially have easier access to their places of work. Additionally, mixed use design makes it more convenient to access amenities without the use of a car because several necessary destinations can be clustered together rather than spread throughout a city.

HOUSING CHOICES. A variety of housing choices in every community gives people more freedom to choose where they live. This can improve access to daily services as well as make it more convenient for them to get to work.

Chapter 1 ADOPTION OF UNIFORM CODES

4-1-1. Adoption of Uniform Codes.

The following codes are hereby adopted for use as part of the Sandy City Revised Ordinances for use in Sandy City, State of Utah:

- (a) The 2015 Edition of the International Building Code, subject to the amendments to IBC Applicable to Sandy City set forth in this Chapter 1.
- (b) The 2015 Edition of the International Mechanical Code.
- (c) The 2015 Edition of the International Plumbing Code.
- (d) The 2014 Edition of the National Electrical Code.
- (e) The 2015 Edition of the International Fuel Gas Code.
- (f) The 2015 Edition of the International Energy Conservation Code .
- (g) The 1997 Edition of the Uniform Code for the Abatement of Dangerous Buildings.
- (h) The 2015 Edition of the International Residential Code.
- (i) The 2015 Edition of the International Existing Building Code.

(Ord 16-32, Amended 9/27/2016)

4-1-3. Amendments to IBC Applicable to Sandy City.

- (a) The following amendments are adopted as amendments to the IBC applicable to Sandy City:
- (1) A new IBC, Appendix L, is added and adopted as follows: "Appendix L BUILDINGS AND STRUCTURES CONSTRUCTED IN AREAS DESIGNATED AS WILDLAND-URBAN INTERFACE AREAS
- AL 101.1 General. Buildings and structures constructed in areas

designated as Wildland-Urban Interface Areas by Sandy City shall be constructed using ignition resistant construction as determined by the Fire Marshal. Section 502 of the 2006 International Wildland-Urban Interface Code (IWUIC), as promulgated by the International Code Council, shall be used to determine Fire Hazard Severity. The provisions listed in Chapter 5 of the 2006 International Wildland-Urban Interface Code, as modified herein, shall be used to determine the requirements for Ignition Resistant Construction."

- (2) In Section 504 of the IWUIC Class I IGNITION-RESISTANT CONSTRUCTION a new Section 504.1.1 is added as follows:
 "504.1.1 General. Subsections 504.5, 504.6, and 504.7 shall only be required on the exposure side of the structure, as determined by the fire code official, where defensible space is less than 50 feet as defined in Section 603 of the 2006 International Wildland-Urban Interface Code."
- (3) In Section 505 of the IWUIC Class 2 IGNITION-RESISTANT CONSTRUCTION Subsections 505.5 and 505.7 are deleted.

ORDINANCE 17-20

AN ORDINANCE AMENDING THE SANDY CITY FIRE CODE BY ADDING A NEW CHAPTER 11, "INSPECTION RECORDS"; ALSO PROVIDING A SAVING CLAUSE FOR THE ORDINANCE AND AN EFFECTIVE DATE.

WHEREAS, it is necessary to amend the Sandy City Fire Code by adding a new Chapter 11, "Inspection Records"; and

WHEREAS, Section 10-8-84, Utah Code Annotated, authorizes such amendment in order to protect the public health, safety and welfare of the City;

NOW, THEREFORE, BE IT ORDAINED by the City Council of Sandy City as follows:

- Section 1. The Sandy City Fire Code is hereby amended by adopting a new Chapter 11, "Inspection Records", as set forth in **Exhibit A** which is attached to and incorporated in this ordinance.
- Section 2. All former ordinances or parts thereof conflicting or inconsistent with the provisions of this ordinance or of the Code hereby adopted are hereby repealed.
- Section 3. The provisions of this ordinance shall be severable; and if any provision thereof, or the application of such provision under any circumstances is held invalid, it shall not affect any other provision of this ordinance, or the application in a different circumstance.
- Section 4. This ordinance shall become effective upon publication of a summary thereof and the City Recorder is hereby directed to publish such summary as soon as practically possible.

EXHIBIT A

Chapter 11 INSPECTION RECORDS

8-11-1. Records Reporting System.

The Fire Chief shall require and enforce a records reporting system for submission and retention of fire inspection, testing and maintenance reports resulting from inspections, tests and maintenance of building fire protection and related systems including, but not limited to: fire sprinkler systems; fire alarm systems; hood fire suppression systems; FM-200 systems; specialized fire suppression systems; spray booths and fire pumps. The records reporting system may be provided by a single-point repository service vendor under contract with Sandy City.

8-11-2. Inspector and Owner Compliance.

- (a) Records of all required fire protection and related system inspections, tests and maintenance shall be maintained on the premises for a minimum of three (3) years and shall be submitted as prescribed by the Fire Chief within five (5) working days after the inspections, tests, or maintenance are completed.
- (b) Any person who performs an inspection, testing, installation or maintenance on any fire protection or related system in any building shall use the required records reporting system, which may require reports to be submitted to an approved single-point repository service vendor in a format compatible with such service. Fees, as applicable, will be paid by the person who performed the inspection, test, installation or maintenance to the approved single-point repository service vendor.

ORDINANCE #17-21

AN ORDINANCE OF SANDY CITY, UTAH DESIGNATING WILDLAND URBAN INTERFACE AREAS OF SANDY CITY AND ESTABLISHING AN EFFECTIVE DATE

WHEREAS, Utah Code Annotated §15A-2-103 provides in part as follows:

Consistent with Title 65A, Chapter 8, Management of Forest Lands and Fire Control, the Legislature adopts the 2006 edition of the Utah Wildland Urban Interface code, issued by the International Code Council, with the alternatives or amendments approved by the Utah Division of Forestry, as a construction code that may be adopted by a local compliance agency by local ordinance or other similar action as a local amendment to the codes listed in this section.

WHEREAS, in accordance with Utah Code Annotated §15A-2-103, the Sandy City Council desires to adopt the 2006 edition of the Utah Wildland Urban Interface Code, issued by the International Code Council, with the alternatives or amendments approved by the Utah Division of Forestry.

WHEREAS, Utah Code Annotated §15A-4-107 identifies amendments to the International Building Code including "Amendments to IBC applicable to Sandy City," which include amendments related to the Wildland Urban Interface.

WHEREAS, in accordance with Utah Code Annotated §15A-4-107, the Sandy City Council desires to incorporate the applicable "Amendments to IBC applicable to Sandy City" into the Sandy City Code.

WHEREAS, the Sandy City Council has determined that certain geographical areas within the corporate boundaries of Sandy City shall be subject to the Utah Wildland Urban Interface Code as amended.

WHEREAS, the Sandy City Council desires to adopt an official map designating areas subject to the Utah Wildland Urban Interface Code as amended.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Sandy City, State of Utah, as follows:

Section 1. Sandy City Building and Construction Ordinance section 4-1-1, "Adoption of Uniform Codes", is hereby amended as set forth in Exhibit "A" of this Ordinance.

Section 2. Sandy City Building and Construction Ordinance section 4-1-3, "Amendments to IBC applicable to Sandy City" is hereby added as set forth in Exhibit "A" of

this Ordinance.

Section 3. The "Sandy City Wildland Urban Interface Map" is hereby adopted as set forth in Exhibit "B" of this Ordinance.

Section 4. Effective Date. For the preservation of public health and safety, this Ordinance shall become effective immediately upon first publication of a short summary thereof as provided in Utah Code Section 10-3-711.





Wildland Urban Interface











