**City Code Discussion** 

For discussion item on the August 16 City Council Meeting, Rob Wall, Mike Applegarth, and myself would like to discuss the process we would like to go through to codify and publish the city code. Specifically, we would like to discuss with the City Council the following points:

- 1. What does codification of city ordinances mean and what does it mean to re-codify the city code?
- 2. The pros and cons of outsourcing the codification process.
- 3. What does it meant to publish the city code once the ordinances are codified?
- 4. What features would the City Council like to see in a finished, published code? For example, how important is it to the City Council that the city code be (a) searchable? (b) have links to other parts of the code? (c) be linked to the City Council agendas and minutes? (d) have links to the original ordinances?
- 5. What process we will go through to select a vendor and work with a vendor to get the code codified and published.
- 6. The need to make current aspects of the city code prior to starting the re-codification and publication process.
