### DETAILED REASON FOR REQUEST & EXPLANATION:

Mayor & Council: Attached is a Resolution to notify the Utah County Council of the City's intent to establish a "CITYWIDE TAX TO FUND RECREATIONAL AND ZOOLOGICAL FACILITIES AND BOTANICAL, CULTURAL AND ZOOLOGICAL ORGANIZATIONS IN PAYSON". The notice *initiates* the process that the city needs to undertake to establish a RAP tax. The Utah County Council then needs to respond to the notice from the City within 60 days indicating that *they* will establish a countywide RAP tax or that *they* are not intending to establish such a tax on the county level. Thereafter, the city will continue the process necessary to establish a city RAP tax as outlined in State law.

The imposition of a 0.1% sales and use tax can be used for the funding of recreational, cultural, botanical and zoological organizations and or facilities.

#### **RESOLUTION NO. 2016-04-20**

A RESOLUTION TO NOTIFY THE UTAH COUNTY COMMISSION OF THE CITY OF PAYSON'S INTENT TO SUBMIT AN OPINION QUESTION TO PAYSON RESIDENTS REGARDING WHETHER PAYSON SHOULD IMPOSE A CITYWIDE TAX TO FUND RECREATIONAL AND ZOOLOGICAL FACILITIES AND BOTANICAL, CULTURAL AND ZOOLOGICAL ORGANIZATIONS IN PAYSON

**WHEREAS**, the Utah State Code: (Section 59-12-1401, et. seq.) authorizes a city to submit an opinion question to its voters as to whether or not the City should impose a local sales and use tax of 0.1 percent to fund recreational and zoological facilities and botanical, cultural, and zoological organizations in the city (commonly referred to as a "RAP tax"); and

**WHEREAS**, a city may not impose a RAP tax if the county in which the city is located has either enacted a countywide RAP tax of has declared its intent to submit an opinion question to county voters as to whether the county should impose a countywide RAP tax; and

**WHEREAS**, U.C.A. Section 59-12-1402(6)(a)(i) states that before a city submits an opinion question to its voters regarding the RAP tax, that it must first "submit to the county legislative body in which the city or town is located a written notice of intent to submit the opinion question to the residents of the city or town"; and

**WHEREAS**, State law then gives the county sixty days from receipt of the city's notice to provide the city with either (1) a resolution stating that the county does not seek to impose a countywide RAP tax, or (2) a written notice that the county will submit an opinion question to county voters as to whether the county should impose a countywide RAP tax; and

**WHEREAS**, the city may proceed with its RAP tax election if the county indicates that it does not seek to impose a countywide RAP tax; the city may not proceed with the RAP tax election if the county gives the city written notice that the county will have its own RAP tax election; and

**WHEREAS**, the Payson City Council intends to proceed with an opinion question to the Payson City voters as to whether the City should impose a citywide RAP tax and to provide Utah County with notice or its intent as required by law.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PAYSON, as follows:

- 1. The Payson City Council hereby declares its intent to submit an opinion question to Payson city residents as to whether the City of Payson should impose a local sales and use tax of 0.1 percent to fund recreational and zoological facilities and botanical, cultural, and zoological organizations in Payson.
- 2. The City of Payson hereby gives the Utah County Commission notice of its intent and respectfully requests Utah County respond to this notice as required by law.

3. All acts, orders, resolutions and or rescinded.	rdinances and parts in conflict with this Resolution are hereby
4. This Resolution shall become effe	ective immediately upon adoption.
