Monica Zoltanski spoke regarding a horse riding event at Wrangler Trail head where horse trailers and vehicles were booted by a parking company while parked illegally in a private parking lot. She requested that the parking company hired by the private property owner be investigated by the City.

Mr. Applegarth read a comment from a resident living outside of the City regarding the above mentioned incident at Dimple Dell Park. He cautioned the Council to be very careful if they are thinking about regulating private property and telling business owners who can and cannot park on their property.

Steve Van Maren felt the idea of live streaming was good; but questioned if a short notice would provide enough notice for people to tune in at the right time. He submitted pictures, through Cityworks, of two signs on City fences that have not been removed. He stated that he was very disappointed in the City's ordinance enforcement. He does not know where to go next because Cityworks has not worked for him.
