The Public Hearing was continued from the 9/21/21 City Council Meeting. Mike Wilcox, with Community Development, presented on this item. He provided an overview on the amendments related to Accessory Apartments (Internal Accessory Dwelling Units, I-ADUs). The Amendments to Title 21, Chapter 7, Permitted Land Uses in Residential Districts; Mixed Use, Transit Corridor, and Research and Development Districts; Title 21, Chapter 11, Special Use Standards; and Title 21, Chapter 37, Definitions, of the Sandy Municipal Code. He provided an overview of the amendments and the recommended changes. The Planning Commission forwarded a positive recommendation. Council questions and comments followed.

Public Comment opened:

Mr. Steve VanMaren spoke about the people who recently drowned in New York basement apartments, and suggested the I-ADUs have a secondary egress. Public Comment closed.

Council Member Houseman spoke about the upcoming Utah League of Cities and Towns conference. She is participating as a panelist with Dr. Flint at a workshop on Thursday: "Using USU's Utah Wellbeing Survey Project for Planning". She thanked Administration for their help with the survey conducted in Sandy City.

Chief Cline acknowledged Joe Spicer with the Fire Department. Joe has brought approximately \$1 million dollars to the City through grants. He will be honored tomorrow evening at he RSL game receiving the Community Hero Award. October is Fire Prevention month - "Learn the sound of fire Safety" is the education program sponsored by the Fire Department.

Ms. Brie Debry, speaking on behalf of Amelia Holt, read a statement from Ms. Holt who expressed the need for indoor tennis facilities in the area. There are indoor pools and gyms in the area, but no indoor tennis facilities.

Ms. Debry added her own comments - as a high school tennis coach, our community does need indoor tennis courts. She spoke about the need for the facility to have tournament courts for both pickleball and tennis. These tournaments would bring in revenue.
