Brett Neuman, Finance Department, introduced Jason Burningham with Lewis, Young who provided an overview of the Resolutions under consideration by the Council. The purpose of Resolution 21-38C and RD 21-06 is to give authorization to issue bonds and outline terms of that transaction, for the purpose of refunding (refinancing) our 2007 Soccer Stadium Bonds to achieve savings on the debt payments. Resolution 21-38C is the City's side of that transaction. Specifically, it formalizes agreements associated with the City's pledge of sales tax revenues to cover new bond payments, should other revenues be insufficient. Council questions and comments followed.

Public comment opened.

Mr. Steve Van Maren suggested the Council keep the maximum interest rate allowable in the parameters resolution as low as possible.
